Sub: Engagement of Contract Medical practitioners (CMPs) / (Specialist & General Divisional Medical Officer) over and above the vacancy to contain the spread of COVID -19 Pandemic full time basis on Ahmedabad Division (WR).

In terms of Railway Board's above quoted letters, applications are invited for the posts of Specialist & General Duty Contract Medical Practitioner/Officer (CMPs) at various Hospital of Ahmedabad Division from eligible Doctors from open market and retired Govt. Doctors who fulfil the eligibility criteria specified here under. The engagement is purely on contract basis for a period of 2 (Two) Months i.e. up to 30.06.2021 over and above the vacancy as per local requirement which can be renewed/extended as per Railway Board's further orders.

Qualification:

- (1) For GDMO:- Degree in Medicine i.e. MBBS (recognized by the Medical Council of India include in the first or second, schedule or part eleven of the third Schedule (Other than the Licentiate qualifications to the Indian Medical Council Act 1956). Holders of education*qualifications in Part II of the third schedule should also fulfil the conditions stipulated in Section 13 (3) of the Indian Medical Council Act 1956.
- (2) Candidates should have satisfactorily completed the compulsory rotatory internship.
- (3) For specialist: - DTCD/MD Chest, DA/MD Anesthesia, MD/DNB Medicine.

Age limit: Not exceeding 50 years as on 21.04.2021 which is relaxable by 5 years for candidates belonging to SC/ST & Ex. Serviceman and 3 years for OBC.

- (10) Contract medical practitioners who enter into contract with the Railways will not have any claim or right for his/her continuity in service or automatic extension of the term of contract. Services rendered as a fulltime contract Doctors will not have any bearing in respect of considering of their period in regular selection through UPSC, nor will it confer any right for regularization or absorption.
- (11) Eligible Schedule Caste/Schedule Tribe/ Ex-serviceman/ Other Backward Class candidates may apply along with necessary caste certificate for the same. OBC candidates have to submit certificate to the effect that they do not belong to Creamy Layer, from appropriate authority as per extant rules.
- (12) Eligible and interested Candidates who fulfills the eligibility criteria as per the notification are advised to submit scanned and Signed copy of their application dully filled / signed in the prescribed format along with requisite documents as mentioned in the applications through email on email id srdpoadi14@gmail.com on or before 17.00 hrs.
