If no specialist available GDMO will be considered.

Note:- The maximum age for first time engagement is 53 years and maximum age limit for re-engagement is 65 years or completion of 12 terms whichever is earlier. Each term of engagement shall not exceed more than one year. For retired /Government Doctors ,maximum age limit is 67 years and 7 terms.

Terms and condition of Engagement of Contract Medical Practitioner.

- 1.No.of Terms. The ceiling limit of 12 annual terms shall be counted cumulative for all Indian Railways put together i.e. if a CMP has worked for 08 annual terms on one Zonal Railways, he/she can be engaged for a maximum of 04 annual terms on other zonal railways. The verification regarding the max limit shall be done before hiring the CMP by the verifying their details such as Adhar, Pan card through AIMS Portal.
- 2. <u>Age</u>:-The maximum age for first time engagement is 53 years and maximum age limit for reengagement is 65 years or completion of 12 terms whichever is earlier. Each term of engagement shall not exceed more than one year. For Retired/Government Doctors, maximum age limit is 67 years and 7 term.
- 3. Conduct of Interview :- Interview will be conducted by nominated standing selection committee.
- 4. The termination of Contract. The Contract can be terminated at any time on 15 days notice from either side. The administration reserves the right not to assign any reasons for such termination. However, in exceptional circumstances due to exigencies of service and administrative interest the Contract of CMP may be terminated with immediate effect. In such cases of immediate termination/resignation remuneration equal to the notice period i.e. 15 days shall be payable or recoverable to/from the CMP as the case may be.
- 5. <u>Document Verification</u>:- Candidates appearing for the interview will have to bring one set of self attested photocopy of all the relevant certificates along with the prescribed form(attached herewith) and the original certificates for verification.
- 6. <u>Contract agreement</u>:- A notarized contract agreement will be executed and to be submitted by CMP to Personnel Department.
- 7. Provisional engagement will be given till the verification of documents. Any discrepancy noticed will lead to termination of contract with immediate effect.
- 8. <u>Medical Examination:</u> The CMP will have to undergo General Medical Examination and should be free from communicable diseases.
- 9. The CMP will have to undergo a brief orientation of two weeks period.
- 10.Normally Sundays & National Holidays will be a off .In addition, authorised absence without detriment to the terms shall be allowed at the rate of two days per month to be availed any time during the contract to the extant earned by the CMP till such time.
- 11. Any CMP leaving the place of working should get prior permission from controlling authority.
- 12. There will be daily proportionate reduction from the remuneration in the event the CMP absent himself/herself for periods exceeding those stipulated in the contract.
- 13. The CMP may avail of free medical treatment for self only except the operations categorized as 'Special' in para 622 (8) of Indian Railway Manual 2000 and treatment normally available at Super Speciality centres empanelled

- (if any) on recommendations of regular IRHS Doctors of JRH.
- 14. The CMP shall be governed in respect of matters not referred here, by any orders/amendments to the terms of the contract by Railways from time to time.
- 15. The CMP shall have to perform all the normal tasks as instructed by the departmental In charge or by higher authorities. These include duties in Casualty, ICU, OT or at the place and time of any emergency.
- 16. The CMP will be given one set of First Class Complementary pass for self and family during each contract which can be issued only after completing three months of the contract period.
- 17. No Railway privilege passes/PTOs will be admissible to retired Railway doctors as CMP.
- 18.CMP Cannot /will not
 - a. Give sick/fit certificate beyond 7 days.
 - b. Sanction of any type of leave of any of the regular staff.
 - c. Make any medical recommendation of any kind referred to para 559-564 of IRMM.
 - d. have any financial powers.
 - e.Indent or condemn/recommend any tools and plants etc.
 - f. Perform /involve in any activities that would be considered against of Medical Department /Railways and if found the services will be terminated with immediate effect.
- 19. Duty passes will be issued if deputed outstation. And admissible allowances @ Rs.900/- per day during such journeys subject to fulfilment of other provisions pertaining to daily allowance prescribed in IREC.
- 20.Railway accommodation will be provided if available. And necessary charges like HRA/licence fees, water Charges/electricity charges etc. will be ducted from regular consolidated salary of CMP. No assurance for provision of accommodation.
- 21.CMP will not have any claim for getting permanent post,promotion,seniority, pension,gratuity,or any other benefits available for regular IRHS doctors or ,any kind of remuneration after completing the tenure in Railways.
- 22.All orders issued from time to time by superior officers of JRH should be followed.
