BRIEF HISTORY OF WR:-

The Western Railway (WR) was formed on January 5, 1951, when several state-owned railways merged, including the Bombay, Baroda and Central India Railway (BB&CI), the Saurashtra Railway, the Rajputana Railway, the Jaipur State Railway, and the narrow-gauge lines of the Cutch State Railway. The WR covers 6,508.50 kilometres of routes and serves almost the entire state of Gujarat, as well as parts of Maharashtra, Madhya Pradesh, and Rajasthan.

The WR's history includes:

1867

The first local service was introduced between Virar and Backbay, with one train in each direction.

1899

The WR's headquarters building in South Bombay's Churchgate celebrated its 100th anniversary in 1999. The building is a grade I heritage building and an important landmark on the city's skyline.

2002

The Jaipur and Ajmer divisions of the WR became part of the newly created North Western Railway.

2003

The Kota division of the WR became part of the newly created West Central Railway.

The freight business is the major source of revenue for the Indian Railway. Major commodities carried on Western Railway over its network are Cement, Petroleum products, Indigenous Fertilisers, Sugar, Containers, Coal, and Onion etc.
