II. **Terms and conditions :**

1. The Scheme is valid up to **01.12.2019**.
2. The re-engagement shall be strictly be up to the age of 65 years as on cutoff date **01.12.2019** or till the availability of regular candidates from RRB / RRC / Departmental selection, whichever is earlier.
3. Age of the applicant should not be exceeding 63 years 10 months as on the last date notified for submission of application in the notification.
4. No re-engaged staff will continue in service beyond 65 years of age under any circumstances.
5. The administration has the liberty to terminate the services of the re-engaged employees anytime with notice of 15 days in case their work/conduct is found unsatisfactory.
6. The employees who were removed/dismissed/compulsory retired as a result of disciplinary action or in service Review are not eligible for re-engagement.
7. The re-engaged employees will be entitled to get remuneration as per Railway Board's letter No.E(NG)II/2007/RC-4/CORE/1 dt/-11/12/2009.
8. Selected staff will execute an agreement with administration to abide by all the terms and conditions for re-engagement.
9. Re-engagement is subject to their medical fitness for assessed category.
10. Suitability committee of appropriate level will adjudge the suitability & competency of applicants.
11. Duty hours of re-engaged employee will be same as applicable to the post against which he/she is re-engaged.
12. Retired employees being re-engaged should not have been covered in Safety related retirement scheme / LARSGESS.
13. Retired staff may apply for same category / trade from which he/she retired or other related categories where their past experience may be useful or similar nature of work is involved.
14. Applicant must have minimum qualification as applicable for open market recruitment of that category for which he has applied and is being assessed.
15. Applicant will be able to give three choices of station/units. However, administration will be free to post them anywhere as per requirement.
16. Copy of any one of the following documents should be attached with the application.
 - a. Service Record
 - b. Pensioner Identity Card
 - c. Pension Payment Order



17. The last date for submission of the application is 14.02.2018 upto 18.00 hrs.
18. The staff desirous for re-engagement, should submit their applications in the prescribed format at Annexure-A, by dropping the application in the box kept in Welfare Section of DRM Office, Mumbai Central from 24/01/2018 to 14/02/2018 or by sending through post which should reach by 18.00 hrs of 14/02/2018, i.e. before the last date mentioned above.
19. Applications received after 18.00 hrs of 14.02.2018 will not be entertained.
