Applications are invited for the post of Specialists and General Duty Medical officer at Vadodara division, Western Railway from eligible doctors and retired Government doctors from open market who fulfill the eligibility criteria specified. The engagement will be offered purely on contract basis for a period of one year which can be renewed as a fresh contract on year to year basis, not extendable beyond 12 years or till attaining the age of 65 years whichever is earlier and each term of engagement shall not be more than one year in case of doctors from open market and not extendable beyond five years in case of retired government doctors upto the age limit of 65 years, or till such time doctors selected by UPSC become available whichever is earlier. Applications are also invited from retired Railway doctors for engagement on contract basis.

(C) QUALIFICATION:-

FOR SPECIALIST

- 1) Degree in Medicine i.e. MBBS Recognized by the Medical Council of India.
- 2) Post Graduate Qualification in the relevant subject /field recognized by the Medical Council of India and permanently registered with Medical Council of India
- 3) Three years experience in clinical work after Post Graduation in the specialty concerned as on the date of the interview.
- 4) There will be 5 Years relaxation for SC/ST and 3 Years for OBC

FOR GENERAL DUTY MEDICAL OFFICERS:

1. Degree in Medicine i.e. MBBS (Recognized by the Medical Council of India included in the First or Second Schedule of Part eleven of the Third Schedule other than the Licentiate Qualification to the Indian Medical Council Act 1956) Holders of Educational Qualification in Part II of the third schedule should also fulfill the condition stipulated in section 13 (3) of the Indian Medical Council Act 1956.
2. Candidate should have satisfactorily completed the compulsory Rotatory Internship.
3. The degree should be permanently registered with Medical council of India.

(D) AGE LIMIT:-

1. Not exceeding 58 years as on 31-01-2021 for specialists and Not exceeding 53 years as on 31-01-2021 for GDMO which is relaxation 5 years for SC/ST candidates and three years for OBC

(F) RETIRED GOVERNMENT DOCTORS ENGAGEMENT ON CONTRACT BASIS:-

- Terms and conditions as laid down by Railway Board vide the letter No. 2013/E(GR)II/1/5 dated 09-07-2018 Retired Government Medical Officer of State Government and Central Government Doctors upto the age of 65 years may apply for CMP against the existing regular vacancies on a fix remuneration of Rs. 46,000/- per month (subject to condition that remuneration plus pension drawn by the retired government doctor should not exceed the last pay drawn)

Terms & Conditions:-

1. Number of posts at places specified **B** above are subject to change, offer will be on the basis of actual vacancies available at the time of engagement . Engagement of doctors on contract basis as indicated in the above advertisement may change on joining of doctors on study leave or through UPSC& Posts indicated above may be kept unfilled at the discretion of administration.
2. **Railway administration reserves the right to post /transfer selected CMP's anywhere on Vadodara division in the administrative interest.**
3. Posts indicated above may be kept unfilled at the discretion of administration.
4. Contract can be terminated by the railways at any time during the contract by giving 15 days notice without assigning any reason as per the terms and conditions laid down vide Railway Board's letter no. 96/E(GR)II /9/16 dated 23/02/2000.
5. Contract Medical Practitioners who enters into contract with the railways will not have any claim or right for his /her continuity in service or automatic extension of the term of contract. Services rendered as a full time contract doctors will not have any bearing in respect of considering of their period in regular selection through UPSC, nor will it confer any right for regularization or absorption.

6. Eligible Scheduled caste/Scheduled Tribe/Other Backward Class candidates may apply along with necessary caste certificate for the same. OBC candidates have to submit certificate to the effect that they do not belong to Creamy Layer , from appropriate authority as per extent rules.EWS candidates have to submit necessary certificate as per railway Board Letter No.2019-E(SCT)I/25/1 dated: 07-02-19 (RBENo.21/2019)
7. Doctors serving under State /Central Government /Public Sector undertaking etc. may apply with NOC from the respective organization.
8. Doctors while applying should indicate past service rendered if any including the **period** of contract put in by them on Indian Railway.
9. Eligible candidates who fulfill the criteria as per notification can apply in enclosed prescribed format (Annexure-1) and come for a walk-in-Interview on the Place ,Date & Time mentioned above positively along with all enclosures and original certificate with self attested xerox copies and all original documents.
10. All candidates desirous of Walk -in -interview should report at 9 :00AM on the date of interview . No other intimation will be given separately for the interview. registration for the interview ends at 12:00PM after which No applications will be accepted No application should be forwarded before hand. Candidates should only apply in the Annexure enclosed. Certificate copies of all testimonials and two passport size photographs may be submitted with applications.
