Application are invited for the posts of General Duty Contract Medical Practitioner/Officer's as shown above of Bhavnagar Division from eligible Doctors from open market and retired Govt. Doctors who fulfill the eligibility criteria specified. The engagement will be offered **purely on contract basis** for a period of one to three months which is over and above the vacancies as per local requirement which can be renewed/extended as per Railway Board's further orders if needed. The engagement is at the Divisional Railway Hospital Bhavnagar Para, Bhavnagar-364003. **Proper PPE will be provided while on Duty in Isolation ward.** The date of interview, venue and posts/community wise intake is as under:

Qualification:

FOR General Duty Medical Officer:-

- 1) Degree in Medicine i.e. MBBS(recognized by the Medical Council of India included in the first or second schedule or part eleven of the third schedule(other than the Licentiate qualifications to the Indian Medical Council Act 1956). Holders of educational qualifications in part II of the third schedule should also fulfill the condition stipulated in Section 13(30 of the Indian Medical Council Act 1956.
- 2) Candidates should have satisfactorily completed the compulsory rotatory internship.
- 3) The Degree should be permanently registered with the Medical Council of India.
- 4) There will be 5 years relaxation for SC/ST and 3 years for OBC.

Age limit: Not exceeding 53 years as on 01.04.2021 for GDMO.

CANDIDATES FULFILLING THE ABOVE CRITERIA ALONE NEED TO APPLY.

Other Terms & conditions:

- (1) Doctors serving under State/Central Govt. /Public Sector undertaking etc. may apply with NOC from the respective organizations.
- (2) Doctors while applying should indicate past service rendered, if any including the period of contract put in by them on Indian Railways anywhere in India.
- (3) Retired Govt. Doctor's engagement on contract basis. –Terms and conditions as laid down by Railway Board vide their letter No. 2013/E(GR)II/1/5 of 09.07.2018. Retired Govt. Medical officers of State Government and Central Government Doctors up to the age of 65 years may apply for CMP against existing regular vacancies on remuneration mentioned below. (Subject to the condition that remuneration + Pension drawn by Retired Govt. Doctors should not Exceed the last pay drawn.)**

If Govt. accommodation is provided, an amount equivalent to the sum of HRA & license fee of the accommodation so provided shall be deducted from the monthly remuneration. Daily rate of reduction from the fees for excess absence will be made as per extant rules.

**** For Retired Doctors:- Subject to the condition that remuneration + pension drawn by retired doctor should not exceed the last pay drawn at the time of retirement.**

- (5) Number of posts specified above are subject to change.
- (6) Contract can be terminated by the Railway at any time during the contract by giving 15 days notice without assigning any reason as per the terms and conditions laid down vide Railway Board's letter No. 96/E (GR) II /9/16 dated. 23.02.2000.
- (7) Contract medical practitioners who enter into contract with the Railways will not have any claim or right for his/her continuity in service or automatic extension of the term of contract. Services rendered as a full time contract Doctors will not have any bearing in respect of considering of their period in regular selection through UPSC, nor will it confer any right for regularization or absorption.
- (8) Eligible Candidates who fulfill the criteria as per the notification can apply in enclosed prescribed format (Annexure -1) and come for a Walk-in-Interview on the Place, Date & Time mentioned above positively along with all enclosures and original certificates with self attested xerox copies and all original documents.
- (9) All candidates desirous of walk-in-interview should report at 9.30 A.M. on the date of interview. No other intimation will be given separately for the interview. Registration for the interview ends at 12:00 PM after which no applications will be accepted. No applications should be forwarded before hand. Candidates should only apply in the annexure enclosed.
