The Chief Medical Superintendent, Dahod – Western Railway is inviting Expression of Interest [EOI] for the fresh empanelment of Vendor/Private Medical Store for local purchase of Medicines for Railway Main Hospital- Dahod for the railway beneficiaries of the Dahod. The [EOI] is invited as per the Railway board letter no. 2017/H/4/1/Local Purchase dated 31/10/2018. Those Vendors/Firms who are interested may give their consent for the survey and inspection of their firm with full proposal with discount. The terms and conditions can be collected from the address given below.

1	Name of the work	Fresh empanelment of the Vendor/Private Medical Store for local purchase of Medicines for Railway Main Hospital- Dahod for the railway beneficiaries of the Dahod. The location of the firm should be within the municipal area of Dahod city. The firm offering maximum discount on MRP of the medicine can offer their proposal for medicine. The firm whosoever offers the maximum discount will be empanelled for supply of medicines.
2	Mode of Payment	The payment will be made within 30 days of receipt of the bill for the medicines supplied on local purchase order. The payment mode must be NEFT through finance department of Dahod.
3	Condition to be fulfillment	The firm/vendor supplying the medicines should supply the medicines of manufacturing firm which are registered with Indian Railways.
4	Period of work	The firm/vendor offering the maximum discount will be given the opportunity for empanelment. The empanelment of Vendor/Firm for local purchase of medicines will be for two year which can be extendable on mutual understanding looking to the performance of the firm.
5	Date of submission of EOI	The interested firm / vendor can submit their EOI <u>on or before 17/07/2021 by 17:00 hours.</u>

## TERMS AND CONDITION.

1. The medicine supplied by tie up store should be registered firm with PCMD/WR or Railway Board or any other Indian Railway.
2. If Manufacturing firm s not registered than should be inspected by the Railway authorities, found fit and marketing firm should be registered with PCMD/WR & Railway Board. The list of such firms is available on the website of WR Medical dept. and Railway Board Health Director site. Copy may be obtained from Railway Hospital/Dahod, if required by any one.
3. Medicine of non-registered firm will be procured only when no registered firm is available and the gravity of case after personal approval of DMO/Store or CMS.
4. The offer is opened to all Medical store /hospital/Vendor who are ready to supply to Railway Hospital Dahod Medical store for which the vendor has to submit an application to CMS along with documents required and inspection by the committee nominated.
5. The offer is opened for all medical store registered in the Municipal area of Dahod and agreed to supply medicines at Rly. Hospital, Dahod in reasonable time without any additional charge/cost.
6. The offer will be accepted from registered medical store of Gujarat Govt. who offer maximum discount on MRP.
7. In case of tie up in discount offers by more than one Vendor /Medical store than negotiation will done with such vendor and vendor who is offering maximum discount will be considered for tie up.
8. The period of tie up is normally 02 years & may be extendable as per provision.
9. After tie up medicines will be supplied by the vendor to the Railway Hospital Dahod on demand by concerned Pharmacist on Telephone/Whatsapp/SMS/Mail whichever is suitable and proper PO will be issued by Medical Store on the same day for such items than bill will be generated by Vendor.
10. The Medical Store should normally supply medicines within 04 hrs on receipt of such order normally and in exceptional case on next day. If not in a position to supply any reason should communicate the Store Pharmacist immediately so that Railway hospital can arrange alternate and difference will be beard by Vendor.
11. The bill should be submitted in triplicate to bill passes to Medical store, MH/Dahod for the medicine supply and at the end of month the summary of bills should be submitted in duplicate for arranging payment. The payment will be arranged on receipt of summary within 15 to 20 days after verification from Store by NEFT from associate finance.
12. If there is any delayed in release of payment the vendor should continue to supply uninterrupted. However all efforts will be made for timely payment.
13. In case of emergency the tie up medical store should supply medicines urgently, after duty hours and on holiday also.
14. Kindly submit your offer along with your authorized signature and seal and copy of the same may be kept at yours for future reference.
15. The registration of firm require following documents along with application. :
  1. A qualified manpower: A registered Pharmacist ( Copy to be attached ).
  2. Proper storage and cold chain supply system.
  3. Proximity to Railway hospital not beyond municipal area of Dahod city.
  4. Holding of. valid license of medical store.
  5. Last 03 years turn over supported by CA certificate.
