

The Chief Medical Superintendent, Vadodara -Western Railway is inviting Expression of Interest (EOI) for the Fresh Empanelment of the Private Hospital providing full Multispecialty treatment in Anand city/Rural/or near by for the railway beneficiaries residing near Anand and nearby by city of the Vadodara division. The EOI to be submitted as per the CGHS rates of (Ahmedabad city) updated on 5th May 2021 or lower providing Multispecialty treatment including Cardiac facility and Dialysis facility in Anand city/Rural/or near by mostly under one roof. The interested hospitals may submit their consent for the survey and inspection of their hospital on or before 09/08/2021 along with detailed proposal and rates.

Name of the Work	Fresh Empanelment of the Private Hospital for full Multispecialty treatment including Cardiac facility with Dialysis unit in Anand city/Rural/or near by for the railway beneficiaries of the Vadodara division. The Empanelment will be as per the Railway Board letter no. 2016/H-1/11/58/Policy dated 25/04/2018.
2.	Rate of Payment	a. Payment system will be as per the CGHS rates of Ahmedabad city updated on 5 th May 2021 or lower rates for the listed items /procedures/investigations etc. For the items /procedures/investigations etc which are not listed will be as per the Hospital Rate list with the offered discount or otherwise. b. Medicines and Consumables will be paid as per the MRP with discount offered or otherwise. Implants if listed in CGHS will be paid on CGHS rate otherwise on the MRP with the discount offered or otherwise.
3.	Period of work	The empanelment will be as per the Railway Board policy. This will be for two years from the date of sanction of the empanelment of the Private Hospital. Further extension will be done as per the Mutual Agreement and Railway Board Policy.
