

ENGAGEMENT OF GENERAL DUTY MEDICAL OFFICER ON CONTRACT BASIS (FULL TIME) AT RAILWAY MAIN HOSPITAL, DAHOD WESTERN RAILWAY.

Applications are invited for 06 posts of General Duty Medical Officer on Full Time Contract Basis at Railway Main Hospital, Dahod (Western Railway) from open market who fulfill the eligibility criteria specified below. The engagement will be offered purely on contract basis for a period of one year which can be renewed as a fresh contract on year to year basis, not extendable beyond 12 years or till attaining the age of 65 years whichever is earlier and each term of engagement shall not be more than one year. In case of Retired Govt. Doctors the age limit is 67 years or up to SEVEN Terms or up to the UPSC selected IRMS Doctors available whichever is earlier. Applications are also invited from Retired Govt. Doctors for engagement on contract basis.

- (1) (i) Engagement of Doctors on contract basis as indicated in the above advertisement may be changed on joining of doctors through UPSC. (ii) The Posts indicated above may be kept unfilled at the discretion of Administration. (iii) Contract can be terminated by the Railway administration at any time during the contract by giving 15 days notice without assigning any reason as per the terms and conditions laid down vide Railway Board's letter No.96/E(GR)II/9/16 dated 23.02.2000.
- (2) Monthly Remuneration : GDMO Rs.75,000 The remuneration specified includes amount of HRA and Transport Allowance in case of full time contract doctors. If Railway accommodation is provided to General Duty Medical Officer an amount equivalent to the sum of HRA and license fee of the accommodation so provided will be recovered from the monthly remuneration admissible to the concerned Medical Practitioners.
- (3) Age limit (i) Not exceeding 53 years on 01/01/2024 which is releasable by 05 years for candidates belonging to SC/ST and 03 years for Ex- Servicemen and OBC. (ii) For Retired Govt. Doctors the age limit is 67 Years or up to SEVEN Terms whichever is earlier.
- (4) Qualification\_(i) Degree in MBBS ( recognized by the Medical Council of India included in the first or second schedule or part eleven of the third schedule (other than the Licentiate qualifications to the Indian Medical Council Act 1956) . Holders of educational qualifications in part II of the third schedule should also fulfil the condition stipulated in Section 13 (3) of the Indian Medical Council Act 1956. (ii) Candidates should have satisfactorily completed the Compulsory Rotatory Internship. Candidates fulfilling the above criteria alone need apply. (iii) Doctors serving under State/Central Govt./Public sector undertaking etc. may apply with NOC from the respective organizations. (iv) Doctors while applying should indicate past service rendered . if any including the period of contract put in by them on Indian Railways. (v) Retired Govt. Doctor's engagement on contract basis as per terms and conditions as laid down by Railway Board vide their letter No. 2008/E(GR)II/1/1 dt. 16.07.2012 & 2013/E(GR)II/1/5 dated 09.07.2018. Retired Govt. Medical Officers of State Government and Central Government Doctors up to the age of 67 years may apply for CMP against existing regular vacancies on a fixed remuneration of Rs. 46,000/- P.M. (subject to the condition that remuneration + pension drawn by Retired Govt. Doctors should not exceed the last pay drawn.
- (5) No private practice or any other employment will be permitted during subsistence of contract period.
- (6) All the terms and conditions of Rly.Board amended from time to time shall be binding to Contract Medical Practitioner
- (7) In case of any dispute in respect of notification issued in ENGLISH language will be deemed to be final
