		Senior Divisional Operations Manager is the Administrative head of train operations in Divisional Railway and reporting to DRM, PCOM. He is responsible for management of traffic planning, freight and passenger train operations, safety in train operations.
		Senior Divisional Operations Manager(General) is attending accidents involving traffic staff and associate with conduct of accident enquiries as a representative of Operating department, conducting seminars, traffic safety and rules.
		Divisional Operations Manager is monitoring punctual running of suburban services, preparations of suburban Time Table, crew links, rake links, coaching services. Coordinating with

car sheds for timely supply of rakes for maintaining the link of EMU rakes.

Assistant Traffic Manager(Suburban) the administrative jurisdiction from CCG-Virar for operations(excluding CCG,BCT(M),BCT(L), JOS(AT) and territorial jurisdiction from CCG-Virar suburban operations and coaching operations of BCT Division. Monitoring the punctual running of suburban and coaching trains.

Assistant Operation Manager(Movement) Administrative Jurisdiction ie. JOS(AT) & BSR and territorial jurisdiction of BCT division for freight operations.

Assistant Operation Manager(General) the Territorial and Administrative jurisdiction of BCT Division. Conducting safety inspections and audit as per schedule, monitoring of training and refresher course of Group C & D.

Area Officer/CCG-Administrative & Territorial jurisdiction Churchgate and assist divisional office in preparation of crew schedules for Guards of churchgate-HQ. Coordination with all departments concerned with train working including security including Muncipal ward, BEST and city police in case of any emergency.

Station Director(GAZ)/MMCT-Administrative of jurisdiction BCT(Main),BCT(Local), monitoring punctuality of coaching trains originating/Terminating of Mumbai Central. Assist divisional office ib preparation of coaching Time Table. 
